WORKSHOP DESCRIPTION: This workshop is designed to provide participants with essential and updated information about federal and State special education laws, administrative and judicial rulings interpreting these laws, and current OCR and ISBE compliance issues, as well as practical recommendations for planning proactively to avoid common legal mistakes that school districts make when making decisions concerning the identification, evaluation, programming, and discipline for students with suspected or known mental health issues.

Participants will leave the course knowing federal and State laws, regulations, and guidance that may be applicable to students with mental health issues and disability-related requirements, including but not limited to the Individuals With Disabilities Education Act, the Illinois School Code, and their implementing regulations.

Participants will be able to create procedures to follow when school personnel suspect or know that a student has mental health issues, including evaluations and eligibility determinations, educational programming, and being able to apply factors utilized in case law regarding the

distinction between educational versus medical needs of students with mental illness.

Step-by-Step Directions for Online Membership Registration

Membership enrollment and conference registration is available online. The online registration process will allow you to pay by credit card, check, or purchase order and you will receive an email confirmation!

- 1. To begin the online registration process, go to www.iaase.org
- 2. Click on the words "Online Membership and Conference Registration" This link is located along the upper left margin.

 (Note: do not click on the blue tab that says "Member Portal" This is the member benefit link you will use to access information that is only available to 2017-20187 paid members. Once you have completed your FY18 membership application you will receive an email with the username and password to access information on this link)
- 3. You will see an informational paragraph about online registration. Once you have read it, click on the words "click here"
- 4. You will be taken to a page that has multiple registration links. Remember, by paying your IAASE membership first, you become eligible for the discounted conference registration fees!
- 5. You will then be connected to a page that describes the option you have chosen to register for. If this is correct, click on the words near the bottom of the message that says "Register Now..."
- 6. ARE YOU NEW TO IAASE? If you were not an IAASE member after the 2011-2012 year and did not attend a conference or workshop you will need to create a new account. Click on the red words "Click Here to Create a New Account." You will then be taken to a blank information form that you will need to complete and submit. If you are creating a new password it must be 8 characters long and contain at least one numeral.
- 7. RETURNING IAASE MEMBERS: If you were an IAASE member or attended any of the conferences since the fall of 2011 you already have an account with your own specific username and password. Your username will always be your email address. If you do not remember what your registration password for has been you can click on the words: "Click Here for Lost Password" and your password will be emailed to you. If you remember your password you can fill in the blanks and click to login. This will take you to a page that tells you if you are eligible to renew your membership or if it has already been renewed. If eligible, click on the words "Click to Register." IMPORTANT: This is where you have the opportunity to revise any information that may have changed. Please check it carefully and make any appropriate revisions.
- 8. If you are not certain about which region you work in, click on the words {View Details} where you will see the counties that are included in each of the separate regions.
- 9. Once you have completed the form and made any appropriate revisions click "Submit Membership" at the bottom of the page
- 10. You will be given the option at this point to register another individual for the same event, see a list of events to register for another event, or click to complete the registration and proceed to the checkout.
